### 4:10 PM Property Update - Connie Goers and MG Tindall

- Delay in close of Glen Loch property border issue with undeveloped property in frontage area of ranch
- Needed to provide proof of insurance for lease that information was provided we need to add farm package to lease and make the lease a commercial lease – hope to begin lease Jan. 2018 – New closing date November 30<sup>th</sup>
- Want to make an offer on Foxcroft as soon as closing on Glen Loch is done
- Due diligence 60 days, \$1000 escrow, offer starting at \$1.8 million can go up to \$2.25 million
- Foxcroft is currently boarding 30 horses They will provide information on what leases look like, who's living out there, etc., once offer is made
- Bank will handle due diligence environmental and appraisal
- We will drive inspections
- We will get a second price on moving the arena
- Price on adding electricity, improving roads, etc. to Foxcroft

## 4:20pm Safety Manual – Tommy Middleton

- Section 1.3.2 Reporting of Incidents used OSHA definition clarification of occurrence or incident where occurrence is event with bodily harm and incident is accident or near miss with no bodily harm/ may include property damage
- Gun policy no gun on ranch unless it is locked in a vehicle none on person signage for this
- We need a committee to oversee the safety manual maintenance, including updates or adjustments and changes to policies

- PATH new property will need to go through accreditation
- Threat assessment need committee to look at incidents then discuss what should have been done, what was done, recommendations to improve
- Safety manual approved by majority vote
