1:30 PM Afternoon Board Meeting

• Jimmie led us in a time of devotion and reminded us that God's work is greater than our resources!

1:50pm Gary called the meeting to order

• November Minutes were reviewed. Motion to accept the minutes: Mike Maher, Second: Jimmie Dotson. Passed

2:00pm 2017 Year End budget presentation and questions

- Nel acknowledged that she had an opportunity to review the year end financials and that they numbers are in order
- 150,000 deficit
- Significant time spent in 2017 to build relationships with Foundations
- Several grants were deferred to end of year and will pay in 2018 (\$15,000) some were declined due to Harvey or lack of funding
- Loss of major donor (\$50K plus)

- Some overspending due to designated funds that were not budgeted for (Golf Cart and Capital Campaign \$18K)
- Gary made the point that the bar is set high for income in 2018 and the board must have high visibility and participation in order to succeed
- Patrick made the point that 2017 was a tough year: oil and gas prices, election year, Harvey. The overall feeling is that people are feeling better and encouraged with the economy for 2018 foundation giving should increase as well.
- Motion to accept the 2017 financials: Patrick Flaherty. Second: Chris Osborne. Passed

2018 Budget and Correction Plan

- We have a better understanding of foundations and have aligned those grants with the budget
- There were 16 grants that were held back for Capital Campaign. We will not hold back on those as they become due if appropriate for operational funding vs. capital
- Expenses are up slightly due to staffing and increase in benefits rather than spending
- Mike asked the question: Would our deficit in 2017 affect our grant funding. There was some discussion and the overall thought is that foundations are willing to work with us if we re transparent
- Relocations should not affect our grants either as we will stay in the Montgomery County area
- When we close on the current property those funds will need to go into reserve for capital

Funding History: Sheila

- Note Correction that the percentages for board giving are wrong on 2014 and 2015. They should read as follows: 2014 = 31% (not 69%). 2015 = 10% (not 90%)
- Mike made the points that it would be beneficial to increase our board size, we are too event driven, and that the capital campaign could affect giving. There was discussion that we must still "keep on the lights" and that capital giving has to be over and above the annual giving.

Diversified Funding:

- Should the board host a dinner for the Waste Connections Management Team? YES! It is always a win to say thank you
- Gary asked the board to pray about their giving and a possible 3-year commitment to help our team predict finances. Giving now rather than later in the year is also critical as our income is light in the first 2 quarters
- Other suggestions were:
 - For each board member to fill a table at Breakfast with Champions
 - Increase the ticket price to \$150
 - We need raffle and silent auction items for the Waste Connections golf tournament Mike suggested some really nice wines
 - We need people to play in the Waste Connections poker tournament
 - We will need volunteer hours from board at Champions Club during the Insperity Invitational to help us get funding from PGA
 - How do we get out families to participate in fundraising: discussion we are committed to educating them and giving them tools to give to family, friends and employers for Sponsor a Child, Sponsor a Horse and Matching gift opportunities
 - If 60 clients find 10 people to give \$1/day = \$219,000/year
 - Add a request to any giving cards to pay the credit card fees

- Gary ask that MG and Sheila itemize what we need and send it out to the board
- Motion to approve the 2018 budget: Mike. Second: Connie. Passed

Inspiration 2020 Property Update Timeline

January 17: Gary and MG met with Lacee Diehl at Chicago Title to gain a clear understanding of where they are in respect to being ready to close. While there have been many challenges with the border lines and lack of surveys in the past, Lacee feels confident that they will be prepared to close on March 2. There are three issues to be solved. Chicago Title has resolved one issue. A second is an affidavit to be signed at closing and Chicago Title will take ownership of the 3rd.

February 1: Phone meeting with Gary, MG, Mutual of Omaha (Bank), Linda and Daryl (Buyers) and Joyce (Realtor) to confirm that we are all on the same page and moving forward. Bank established that we are on course to close on March 2. They are close to completing the Underwriting process and will order the appraisal as soon as this is complete.

February 6: Phone meeting between MG and Mike Novelli (Manager at Cypressbrook) Realty and Joyce's supervisor). MG and Mike discussed the history of the sale and how it has put the ranch in a challenging place. I asked for six months lease back at no charge to the ranch. Mike and I discussed several ways to get to this. I reminded Mike that we were not under contract until the affidavit was signed and that I would wait to hear back from him before signing. Joyce emailed the following morning that they would cut their brokerage fee to 41/2%, and the buyers would not charge us a lease payment for 45 days.

February 9: Mutual of Omaha confirmed on February 8, that they are on target for a March 2 closing. They are ready to order the appraisal and environmental study. I have confirmed with Chicago Title that they are also prepared to close. Mutual of Omaha confirms that the mortgage payment will be \$4,600, so we will pay a \$4,000 lease payment.

We are prepared to send an offer to Mike Sedar the day we close. We have not been able to attain information on Mike's status in regards to his contract with the sellers. We are prepared to reach out to the sellers if we are not able to go through Mike.








2017 GIVING REPORT
